Palliative Care

Aim of Activity *

The World Health Organisation explicitly recognises palliative care under the human right to health. Access to person-centred palliative care reduces unnecessary suffering for the person with a life-limiting condition, trauma for their loved ones, and inappropriate use of health resources. Access to quality palliative care continues to be identified as an important need for the Brisbane North PHN region.

Building on previous work, Brisbane North PHN will undertake the following activities under the Greater Choice for At Home Palliative Care measure:

- Strengthening the Brisbane North Community Palliative Care collaborative with the aim of improving connection between

providers to enhance service responsiveness, integration, quality and coordination of care.

- Devise and implement an action plan to increase capacity and capability of community pharmacists in supporting safe, quality palliative care in the community.

Description of Activity *

The Brisbane North Community Palliative Care Collaborative (BNPCC) is an existing group of palliative care stakeholders, including services. Working with the members, Brisbane North PHN will strengthen the BNCPCC. Based on member feedback, this will be achieved through information sharing at regular meetings and working together on collaborative projects.

The collaborative projects will aim for iterative system improvement. Projects will be based on identified need (from Health Needs Assessment and previous consultations) yet allow flexibility for the group to be responsive to common emergent needs. The solutions, including evaluation, will be co-designed, with additional stakeholder involvement as appropriate.

The BNCPCC have identified the following issues on which to focus in 2022/2023:

- Reducing the inequality of access to at-home palliative care for people with a disability through sector engagement and codesign of an action plan. This issue is a common emergent need escalated by the group in 2022.
- Increasing the confidence of health professionals to hold Advance Care Planning and end of life discussions by investigating and employing opportunities to improve soft skills such as listening and tender conversation skills. This was identified as one of the top priorities by the BNCPCC on review of all consultation and feedback in 2021/22.
- Improve awareness and access of palliative care by hosting an event to share current palliative care information including services, education, and supports available in the region. This addresses a need identified in the the 2020-2021 Primary Palliative Care consultation and current Health Needs Assessment.

The collaborative projects will be supported by the Brisbane North PHN project lead who will manage and progress the work on behalf of the BNCPCC between meetings.

As the group bond strengthens, the ability of the group to undertake larger and more complex system level change should increase. It is forecast, this activity will be ongoing throughout the duration the Greater Choice for At Home Palliative Care measure.

All activities outlined will continue to reference the Palliative Care in Brisbane North Current State Summary which was first created in 2022 as part of the Greater Choice for At Home Palliative Care measure. Its currency will be maintained as throughout the Greater Choice for At Home Palliative Care measure by the Project Lead. This living contemporary document will ensure all relevant stakeholders are consulted, relevant standards, legislation and documents are considered, and work is not duplicated

Brisbane North PHN will commission the creation and implementation of an action plan to increase capacity and capability of community pharmacists in supporting safe, quality palliative care in the community.

Facillitated by a commissioned provider, peak bodies for pharmacy and palliative care, the BNCPCC, interested community pharmacists and other stakeholders, will be engaged to develop an action plan to empower Brisbane North community pharmacists in palliative care. The activities will enhance previous and current projects by promoting existing resources (e.g., palliPHARM), facilitating access to existing programs (e.g. PEPA) and building on and learning from previous experience (e.g. Adelaide PHN and North West Melbourne PHN community pharmacy in palliative care projects). The action plan will aim to meet the needs identified in the 2022 community pharmacist consultation, be responsive to the changing environment and align with existing strategies and plans. The action plan design, activities and timeframe will depend on scope, current climate and agreed goals.

All activities outlined will continue to reference the Palliative Care in Brisbane North Current State Summary which was first created in 2022 as part of the Greater Choice for At Home Palliative Care measure. Its currency will be maintained as throughout the Greater Choice for At Home Palliative Care measure by the Project Lead. This living contemporary document will ensure all relevant stakeholders are consulted, relevant standards, legislation and documents are considered, and work is not duplicated

The Brisbane North Community Palliative Care Collaborative have been consulted on the prioritised needs and strategies..

The Metro North Palliative Care Service will also continue to be engaged to ensure congruence and complementarity between the Metro North Hospital and Health Service Palliative Care Clinical Service Plan and related strategies, and Brisbane North PHN's activities.

State and National palliative projects and schemes have and will continue to be consulted to strategically align to maximise impact and avoid duplication. Initiatives to consult include PEPA, IPEPA, ELDAC, Specialist Palliative Care in Aged Care (SPACE), PalAssist, PalConsult, Medical Aid Subsidy Scheme Palliative Equipment Program (MASS PCEP), PCOC, Gwandalan, Caring@home, PalliPHARM, Queensland Voluntary Assisted Dying (VAD) Implementation, End of Life Conversation Simulations, other PHN projects funded by Greater Choice for At Home Palliative Care measure, and other related internal PHN projects

Organisations consulted and will continue to be engaged include the Office of Advance Care Planning, Advance Care Planning Australia, Palliative Care Queensland, Palliative Care Australia, Cancer Council Queensland, Centre for Palliative Care Research and

Education, Residential Aged Care District Assessment and Referral Service (RADAR; Metro North Health) and other PHNs. Public and private residential aged care facilities, public and private hospitals, general practices and other health providers within the region may be consulted on specific aspects throughout the project.

The Brisbane North Community Palliative Care Collaborative currently has a First Nations representative. Additional consultation, collaboration and partnership with Aboriginal and Torres Strait Islander consumers and service providers will be undertaken as required with each activity to ensure cultural safety and appropriateness.

The Gwandalan Palliative Care Project (a nationally funded Aboriginal and Torres Strait Islander culture upskilling project) will be consulted to see where collaboration, integration or promotion can be undertaken to leverage project work in the Brisbane North region

Collaboration

The PHN will work as part of the Brisbane North Community Palliative Care Collaborative to shape activities which respond to the prioritised needs of the region.

The PHN will also collaborate with The Metro North Palliative Care Service, private and non-government specialist palliative care services and government funded palliative care projects where appropriate to maximise resource investment, reach and outcomes for the region.

Brisbane North PHN (the PHN) has received funding from the Department of Health, Primary Health Care Development Program to lead the Bribie Island After-Hours Pilot Project to:

- · Improve access to after-hours services for residents of, and visitors to, Bribie Island
- · Create a sustainable, blended payment after-hours model of care for Bribie Island residents that is appropriate for the regions specific needs
- · Reduce pressure on nearby emergency departments by providing after hours primary care services
- · Evaluate the effectiveness of blended funding models with the view to expand the model to other areas in need

Description of Activity *

The Bribie Island After-Hours Pilot Project has been established to support the delivery of after-hours primary care services on Bribie Island and surrounding suburbs.

The PHN will procure an after-hours provider or providers through an open tender process to deliver primary health care services to residents and visitors of Bribie Island. Service delivery will occur from July 2022 through to June 2024.

The successful provider/s will utilise available pilot funding, in-kind contributions of partners and make optimal use of available funding under the Medicare Benefits Schedule (MBS) to deliver and evaluate the pilot.

Ideally, the Bribie Island After-Hours Pilot will be monitored and evaluated via reporting against a performance framework comprising a focus on outputs (e.g. the outputs identified in the co-design process)
