The Brisbane North PHN combined 4 streams of funding - CoS. NPS-M. Psychological Therapies and Care Coordination to create

integrated mental health service hubs that were placed in three hospital catchments to meet the needs of people in the Brisbane North area. The integrated mental health hubs are part of a stepped care approach to mental health, where people's needs are assessed and understood, and they are easily connected to the right service.

The overall aim of the integrated service hubs is to support people with severe mental illness to:

- live well in the community;
- access integrated clinical and non-clinical services, matched to their level of need; and
- achieve their recovery goals.

The overall expected outcome of the funding is improved well-being for people with severe mental illness.

Aim of Activity *

Early and easy access to health services are key factors to promoting positive health outcomes and sustain recovery, particularly for people experiencing severe mental health concerns who are at higher risk of experiencing chronic disease and other health conditions. Service navigation activities aim to improve integration of local health services, promote multi-disciplinary care, and make the health system more accessible.

The aim of this activity is to address service gaps by providing support, including intake and assessment services, via a telephone service and online service navigation assistance via the My Mental Health website. The activity aims to support consumers, carers, referrers, service providers and health professionals to enable appropriate referrals and access to PHN commissioned and other relevant mental health, alcohol and other drug and suicide prevention services.

Description of Activity *

The Service Navigation team based at Brisbane North PHN will continue to assist potential clients and referrers to make referrals to psychological services, process referrals and check accuracy of referrals as an administrative intake function.

This activity will be achieved by providing intake and assessment services and on referring to contracted providers to deliver structured. time limited. evidence-based psychological therapies that are embedded into a wider range of services and supports

that are funded or provided from other sources. This will increase access to integrated services with 'wrap around' supports.

This activity will be expanded as part of the rollout of the national Head to Health intake and assessment telephone service. The Head to Health service is intended to promote consistent triage (Initial Assessment and Referral - IAR) and provide an entry-point into and between all community mental health services. To establish the new Head to Health service significant work will be undertaken to implement new service model including moving to a single national phone number, recruit appr opriately qualified staff including peer workers, expand the service operating hours, and align the service with Metro North Hospital and Health Service phone triage service - MH CALL and other community mental health services.
