## Project background

In 2019, Brisbane North PHN conducted an after-hours needs assessment. The findings of the needs assessment indicated that there were no after-hours services available on Bribie Island and that members of the local community were required to travel a considerable distance to access after-hours primary care.

Brisbane North PHN has engaged Beacon Strategies to engage stakeholders to inform the development of an after-hours service delivery model for the Bribie Island community.

Brisbane North PHN is aware that there are a number of other after-hours initiatives being currently scoped for Bribie Island, including the development of a State-funded satellite hospital and other privately funded primary care services. It is the intent of this project to not duplicate these initiatives but ensure they are complementary of each other.

The scope of this project includes engagement with a broad range of stakeholders (e.g. community, general practitioners, practice staff and many more), facilitation of a co-design process to design an appropriate after-hours model of care for Bribie Island and deliver a report of findings and recommendations to Brisbane North PHN to guide next steps. Brisbane North PHN is committed to understanding the local issues and needs of the Bribie Island community, prior to progressing any potential solution.
