Brisbane North PHN supports clinicians and communities in Brisbane's northern suburbs, Moreton Bay Regional Council and parts of Somerset Regional Council. It covers approximately 4,100 km<sup>2</sup> of urban, regional and rural areas, with a population of over one million.

We are one of 31 Primary Health Networks across Australia.

We work with local communities, consumers, carers, health professionals, hospitals and community providers to understand our community and their needs. We then engage stakeholders to design and commission programs and services to meet those needs.

- provide public relations and policy advice to the PHN's senior leaders
- writing, proofing and development of high quality articles for internal and external publications, website content, media releases, grant submissions, tenders and business cases.
- interpret relevant data and information to inform the PHN's policy positions, and support the development of policy briefs and submissions to government policy processes
- provide communications support and advice to teams across the PHN
- record and report the PHN's PR activities to internal and external stakeholders.

## **Key selection criteria**

Within the context of the key outcome areas described above, the ideal applicant will demonstrate the following:

### **Qualifications and experience**

- a degree in communications, journalism, public relations or related fields or be able to demonstrate recognised skills and relevant experience.
- at least two years of experience in a similar role
- knowledge and experience in public relations, including media liaison, political engagement and social media
- excellent verbal and written communications skills
- ability to produce high quality articles for internal and external publications such as media releases, grant submissions, tenders and business cases.
- ability to analyse a range of complex information
- experience informing policy positions and developing policy briefs and submissions to government policy processes

- experience developing and implementing communications plans
- advanced skills in Microsoft Word, Outlook, Excel and PowerPoint
- demonstrated understanding of the not-for-profit healthcare industry is desirable
- experience in using CMS software is desirable
- experience in design, i.e. Adobe Creative Suite (Photoshop and InDesign) is desirable.

### **Capabilities**

The Brisbane North PHN Leadership Capability Framework applies to all roles within the organisation. Applicants must address these capabilities.
