Key messages from Department of Health:

Australian Immunisation Register

- Remember to check the Australian Immunisation Register (AIR) to ensure the correct vaccine is provided to individuals as a second dose.
- It's important that both doses should be of the same vaccine.
- If a patient advises that they have already received the first dose of a COVID-19 vaccine and they are not a returning patient to your clinic please check the AIR to confirm what vaccine was given as the first dose.

Consent

The [COVID-19 vaccine consent form](#) has been revised by Australian Technical Advisory Group on Immunisation (ATAGI) and updated on the Department of Health website.

The easy print versions and translated versions have been removed and will be available once they have been updated.

Other patient and provider information resources will be published as the National Centre for Immunisation Research and Surveillance (NCIRS) update over the weekend. We will provide these links as soon as they are available.
